

# High-Level Objectives



## Scientific Objectives:

- To understand the process of radicalization and its main drivers
- To detect which radical individuals have the potential to become violent before they act.
- To discover the unexpected, radical agents with behaviour that do not fit with the main model.

## Technical Objectives:

- The translation of a disruptive socio-psychological model into algorithms for the detection of potentially violent acts before they happen.

## Commercial Outcome:

- A software product, to be marketed to LEAs, which will aid them in the early detection of potentially violent acts and individuals.
