Created in 2008:


To increase European sustainable growth and competitiveness by

- Reinforcing the innovation capacity of the EU
- Creating the entrepreneurs of tomorrow



#### How does the EIT work?

 Full integration of all three sides of the Knowledge Triangle through Knowledge and Innovation Communities (KICs)



Boost the innovation process from:

- → idea to product
- → lab to market
- → student to entrepreneur



#### What is a KIC?

 A KIC is a highly autonomous partnership of top-class higher education institutions, research organisations, companies and other stakeholders in the innovation process that tackles societal challenges through the development of products, services and processes and also by nurturing innovative entrepreneurial people.

# KICs offer a new way of addressing Societal Challenges


#### Main characteristics


- long-term strategic approach at least 7 years!
- high degree of integration the KIC Legal Entity
- effective governance and management: leadership by a Chief Executive Officer (CEO) and an executive management team
- clear targets and deliverables each KIC sets up business plans with measurable deliverables
- smart funding & high degree of commitment from partners (EIT funding to KICs is max. 25% of their total budget on average, with 75% to be attracted from other sources public and private)
- the co-location model




#### The co-location centres: bringing people together in new ways

- Each of the KICs operates across 5 or 6 innovation hubs called co-location centres
- KICs give EU dimension to the hubs
- There are currently 19 co-location centres spread across Europe





#### **14 February 2014**

Publication of the 2014 Call for KICs

#### 14 March 2014

• Information Day for applicants in Budapest

#### 10 September 2014

• Close of the 2014 call for KICs (at least 6 months after launch of the call)

#### **09 December 2014**

Designation of new KICs by EIT GB



# 2014 Call for KICs proposals – General information

- Call package published
  - Call text
  - Selection Criteria
  - Framework of Guidance
  - Principles for financing, monitoring and evaluating KIC activities
  - EIT Financial Regulation
- One single call in 2014 for Healthy living and active ageing and Raw materials
  - Same eligibility and selection criteria for all thematic fields
- One proposal from each of the thematic fields will be designated by EIT GB



# 2014 Call for KICs proposals – Why is it special?

- Call for selection and designation
  - Funding comes after!
  - Implementation comes after!
- Selection of an integrated partnership
- No list of activities
- Indicative nature by design
  - Broad thematic factsheets
  - Flexibility and creativity



# 2014 Call for KICs proposals – What has changed?

Compared to the 2009 Call, there is a particular focus on:

- Economic and social impact
- The business model and financial plan
- Demonstrating commitment, including financial commitment
- Strong and diverse partnership



# 2014 Call for KICs proposals – Selection Criteria

# Strategy 30 points

- Strategic approach
- Added-value, innovativeness and synergies
- KIC partnership

# Operations 35 points


- KIC governance
- Leadership and operations
- KIC business model and financial plan

# Impact 35 points

- Impact and Competitiveness
- Outputs (KPIs) and KIC scoreboard
- Communication, outreach and dissemination



# 2014 Call for KICs proposals – Evaluation process





# 2014 Call for KICs proposals – Evaluation process

#### **Panel of Experts**

- Five experts per thematic area (three thematic and two horizontal experts)
- Experts will evaluate proposals against the selection criteria

#### **Final Recommendation Panel**

- **Report** to the EIT Governing Board containing an overview, including strengths and weaknesses, of the three highest-ranked proposals per thematic area
- Recommendations on the way in which these proposals may need to be improved and/or strengthened



# 2014 Call for KICs proposals – Evaluation process

# **EIT GB Hearings**

- Hearings with representatives from the **three highest-ranked** proposals from each thematic area
- Hearings will take place at the EIT premises in Budapest on 9 December 2014
- Designation of **one KIC** per thematic area



# 2014 Call for KICs proposals – Start-up phase

#### What happens if you win the KIC bid?

- The modalities of the Start-Up Grant will be communicated to the new KICs shortly after the designation decision of the EIT Governing Board in December 2014
- These modalities will be included in a Start-Up package, comprising a Roadmap for the first year of operations



# 2014 Call for KICs proposals – Start-up phase

The EIT may award a grant up to EUR 4 million to each of the two new KICs.

The grant may cover, for example, the following activities:

- Establishment of legal structures, including the set-up of the KIC Legal
   Entity (LE)
- Recruitment and appointment of a CEO and other core staff
- Coordination and signature of the Internal Agreements
- Preparation of the first 2016 KIC Business Plan
